PERMIT TO CONDUCT BINGO

Pursuant to the Gaming and Wagering Commission Act 1987 ("the Act"), the Gaming and Wagering Commission grants a permit to conduct Bingo to Perth Golf Club Inc, subject to the conditions listed below:

Premises

Perth Golf Club 1 St Georges Terrace PERTH WA 6000

Conditions

- 1. Valid from 29 June 2017. (Also refer to the list of approved events/session dates and times on the last page of this permit.)
- 2. Persons paid for assisting in the conduct of bingo must hold a valid gaming operator's certificate.
- 3. A financial return to be lodged within 7 days of the end of each calendar month (form enclosed for first return).
- 4. If the permit is conducted on premises licensed under the Liquor Control Act 1988 or by a person who holds a licence or permit under that Act, any restrictions or conditions applying to the Liquor Licence or permit on that premises shall apply.
- 5. Each bingo session shall be controlled by the permit holder, or a member of the organisation to which the permit has been issued, nominated by the permit holder. The permit holder is not permitted to participate in the playing of bingo. The person in control of the session shall determine any disputes.
- 6. A session of bingo shall not exceed a period
 - (a) of three hours; or
 - (b) thirty two (32) games whichever is the shorter
- 7. No charge shall be made for admission to any bingo session other than for the cost of cards.
 - (a) the price of a card shall not be more than 30 cents
 - (b) the price of a Flyer Sheet shall not exceed \$3.00.
- The total of all prizes paid for each session of bingo shall be calculated on the bingo gross receipts for the session in accordance with the following table.

9. Goods may be given as prizes subject to:

- (a) The aggregate value of the prize goods for the game is not to exceed \$1,000; (b) a player who is awarded prize goods must be offered money to the value of the goods as an alternative prize and may choose to take the money or the prize; and (c) where there is more than one winner in relation to a prize that consists of, or includes goods, and it is not possible to share the goods equally among all winners, then money to the value of the goods must be shared equally among all the winners in that game.
- 10. Unless prior approval is obtained from the Gaming and Wagering Commission in writing, expenses shall not exceed 20% of the gross receipts. [For the purpose of this condition, receipts from bingo and from any lottery/raffle conducted under section 103 (other than a standard lottery or a trade promotion lottery) and any continuing lottery (hand held break open tickets) are included in the calculation of gross receipts.]
- 11. All cards used in any one game of bingo shall bear the same serial number, and that number shall be announced, by the caller, to all players immediately before the commencement of each game.
- 12. Immediately prior to the commencement of each game the caller shall announce the value of the prize to be awarded for that game.
- 13. No prize shall be awarded to any player, unless all the relevant numbers in respect of the prize to be awarded, on the face of the card held by such player, have been properly called.
- 14. The prize or prizes for each game shall be paid as soon as is reasonably possible after the conclusion of the game to which the prize or prizes relate. In the event of more than one winner in any one game, the prize money must be shared equally between such winners.
- 15. A Jackpot prize can be offered from EITHER receipts from that session of bingo, or from other funds. The prize cannot be offered from a combination of other funds and receipts from that session of bingo.
 A jackpot prize may be offered up to a maximum value of \$3 000 dollars. If the jackpot is provided from funds other than the receipts from that session of bingo it shall not be included in the total of prizes for that session, or the total value of incentives, or the calculation of expenses. If the funds are provided from the receipts of the session they should be included.
- 16. The permit holder shall keep, or cause to be kept, an accurate record of the bingo gross receipts, the amount of prizes awarded, and obtain and keep for a period of twelve (12) months after the expiration of the permit receipts or other proof of payment made for all expenses relating to the conduct of each session of bingo.
- 17. The permit holder shall furnish the Gaming and Wagering Commission with all such information (including copies of documents) relating to the subject of the permit including but not limited to information relating to the disbursement of moneys (particularly the purpose or purposes to which they were applied) constituting the gross receipts from the gaming or lottery the subject of the permit as the Gaming and Wagering Commission may from time to time require.
- 18. No other game of chance shall be conducted, or permitted to be conducted, on the same premises used for the conduct of any session of bingo, other than a continuing

- lottery, a lottery deemed to be permitted under section 103 of the Act, a standard lottery and a trade promotion lottery.
- 19. A minimum of two "spotters", who shall not be permitted to play, shall be provided where a session has more than 100 players
- 20. At the conclusion of each game of bingo, winning card(s) numbers shall be called back and shall be checked with the drawn numbers by two unsuccessful players in such game. The unsuccessful players shall not be the same people for each call back of numbers.
- 21. The permit holder shall within 7 days of the end of each month furnish a financial return in accordance with the regulations together with the 1% surcharge to the Gaming and Wagering Commission.
- 22. The permit holder shall keep copies of all "Bingo Financial Returns" for a period of twelve (12) months.
- 23. No person shall prior to any session of bingo announce, or cause to be announced, advertise, or cause to be advertised the value of any prize, projected value, estimated value or potential value of a prize at that session.
- 24. These conditions shall be displayed in the following locations on the premises:
 - a) in close proximity to the caller.
 - b) in close proximity to the players.
 - c) in close proximity to the entrance of the premises.
- 25. The permit shall be displayed in a prominent location on the premises.
